RULES

1. This is a NYWAY Tournament.
2. Place finishers 1-4 will qualify for the NYWAY State Championship Tournament to be held on March 15 -17, 2013 in Elmira, NY. If a weight class has 17 or more wrestlers than the top 5 place finishers will qualify for the State Championship Tournament.
3. You must be a New York State resident and NYWAY member in order to participate in this tournament. No cards will be sold on site.
4. **Wrestlers are required to wrestle at two qualifying events in order to compete in this tournament. Division 4 & 5 wrestlers are exempt if they competed on their Junior Varsity or Varsity teams. Qualifying events are listed at http://section6youthwrestling.com/NYWAY_Far-West_Region.html**
5. NYWAY tournaments will follow the rules contained in the National Federation of State High School Associations Rules book unless otherwise noted.
6. Wrestlers must compete only in their age group.
7. Wrestlers can compete in only one weight class.
8. Bout lengths are: 1-1-1 for Divisions 1, 2 & 3 and 1:30, 1:30, 1:30 for Divisions 4 & 5.
9. Overtime will follow the NFHS three stage process.
10. Hair covers (either attached or unattached) are required when hair length is outside NFHS guidelines.
11. No weight changes are permitted after 03/08/2013. There will be no weight allowance, wrestlers not making weight will be scratched and no refunds will be issued.
12. Wrestlers must reside or be a member of a club that is located in one of the following counties: Erie, Niagara, Orleans, Genesee, Wyoming, Chautauqua and Cattaraugus in order to participate in this tournament.
13. Wrestlers, parents, and coaches are expected to behave in an appropriate manner at all NYWAY tournaments, practices, and events. Poor behavior including profanity and abusive language will not be tolerated and violators will be subject to immediate ejection.
14. If ejected from a NYWAY Tournament, that respective wrestler or coach will not be allowed back to the next NYWAY event. Repeat offenders may be permanently barred from NYWAY events.
15. No weight classes will be combined.
16. This tournament will use Double Elimination Format, weight classes of 6 or less wrestlers will be run as a Round Robin.
