Wrestling to begin at 9:00 am – Limited to the first 300 Wrestlers.

Rules:

1. NYS Modified High School – bout length 1 minute; 1 minute; 1 minute; OT is 30 sec
2. Intermediate bout length 1-½ minutes; 1- ½ minutes; 1-1/2 minutes;
3. NYS Certified referees for upper age; experienced adult volunteer for lower age groups;
4. No JV or Varsity experience allowed;
5. Criteria for 1st, 2nd, 3rd, 4th;
 - a. 1st criteria: won/loss record;
 - b. head-to-head winner;
 - c. # of pins;
 - d. Total points; and
 - e. Total takedowns.
6. Tournament director reserves the right to combined or eliminate weight classes; 10% weight difference;
7. Age as of December 14, 2013. Proof of age required if contested and agreed upon by the tournament director. Each weight class is made up of wrestlers who ACTUAL weights are closest to each other; taking into account experience.
