



2014 Second Annual Electric City Fall Brawl Round Robin Tournament

Date: Saturday, October 25, 2014

Location: Scranton High School, 63 Munchak Way, Scranton, PA 18508

Times: Coaches' Meeting 8:30 am; Wrestling Begins at 9 am **SHARP**.

Individual Awards: Trophies for Place Winners 1st – 3rd.

Team Awards: Trophies for Top 3 Teams; While all wrestlers are welcome, only teams that wrestle as part of a league representing a school will be eligible for team awards. NO TRAVEL WRESTLING TEAMS WILL BE ELIGIBLE. Also, wrestlers must be a member of the team they are representing at the tournament for either the 2013-2014 or the 2014-2015 seasons to be eligible to earn team points. NO RECRUITING OUTSIDE YOUR TEAM IS NOT PERMITTED. Place winners from each division will earn points for their respective team as follow: 1st = 5 points, 2nd = 3 points, 3rd = 1 point.

Registration: Pre-Registration Only; No Walk-Ons; Entries will be accepted on a first come basis until our limit of 300 entries is reached; Must be received by October 13th.

Weigh-ins: Honor Weigh-ins certified by coach. Please see Challenge information under rules below.

Entry Fee: \$20.00 per wrestler; Checks payable to: West Scranton Wrestling Club; Mail to: Doug Boyle, 726 Pleasant Avenue, Peckville Pa, 18452.

Divisions: 6 & under; 7 & 8; 9 & 10; 11 & 12 (no Junior High experience); Please note that all seeding will be done by the tournament committee as needed to accommodate for more than 5 wrestlers per round robin class; we will do our best to give each wrestler at least three matches.

Tournament Rules: Age as of date of tournament; Challenges to age/weight must be made during the first round only – proof of age required if challenged and wrestler must be within 2lbs of the actual weight listed on the application; There will be a \$20 charge to challenge a wrestler; If you are correct you will get your money back, if not the club will keep the money; Modified PIAA-PIAA Officials; Periods will run 1-1-1 for 6 & U, 7 & 8, 9 & 10 and 1-1 ½, 1 ½ for 11 & 12; Overtime will be a 1 minute sudden death and 30 second ride out if needed. We reserve the right to alter the rules based on the turnout. Any changes will be communicated during the Coaches' Meeting.
