You may enter 2 age/weight divisions. The Tournament directors will make brackets with five wrestlers closest in weight (up to 8lbs difference). If there are less than three wrestlers with-in 8 pounds they will be asked to move up or have their entry fee refunded.

Age as of March 8, 2015 will determine participant's division

Bout length 1-1-1, Overtime, first point scored wins. Contestants from the same school will be separated where possible. **Trophies awarded for First, Second, Third, Fourth and Fifth places.**
