**WEIGH INS:** Honor weigh ins except for NY Top 100 entries, Sunday Jan 31<sup>st</sup> 7:00-8:30AM

**ENTRY FEE:** Pre-registration by mail only: \$25 per wrestler. NO WALK-INS!! Entries and payment both must be received by Monday January 25, 2016. Limited to the first 250 wrestlers.

**SPECTATOR FEE:** Adults \$3, Students \$1

**FORMAT:** 5-6 Man Round Robin

**AWARDS:** 1st – 3rd places. Team Trophies – 1st-3rd. Team list is 10 wrestlers and must be turned in before wrestling starts.

**DIVISIONS:** Age as day of tournament 1/31/16

6 & under 7 & 8 9 & 10 11 & 12 13 & 14 NO VARSITY!!

Coaches must verify weight. If weight is challenged, wrestler must be within 2 pounds of weight listed on registration form or be disqualified from the tournament. Weight must be challenged before 2<sup>nd</sup> round. Tournament Director has the right to combine weight classes. Wrestlers may wrestle in more than one division but will be required to register for both divisions. NYS Certified Referee's!!!!
