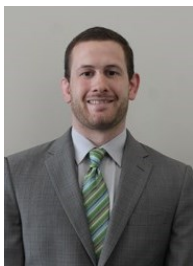


BINGHAMTON UNIVERSITY WRESTLING COACHES



Kyle Borshoff

Head Coach

Kyle is in his third season with the Bearcats, having served as an assistant coach for the previous two years.

Borshoff has played a key role in Binghamton's emergence in the EIWA - one of the most rugged wrestling conferences in the nation.

In the last two seasons, he has helped steer BU to 20 dual wins, four NCAA qualifiers and a 15-8 record against EIWA opponents. Last season, the Bearcats went 8-4 vs. conference foes and placed eighth at the EIWA Championship - the program's highest finish in four years of membership.



Jasen Borshoff

Associate Head Coach

Jasen's reputation and familiarity with the Bearcats' program spans seven years. He coached two NCAA All-Americans, nine NWCA Academic All-Americans and 21 NCAA qualifiers in his previous tenure at Binghamton (2010-17). As a student-athlete at

American University, Borshoff was a four-time EIWA place-winner, NCAA qualifier and two-time Academic All-American. He was a six-time Dean's List recipient who helped the Eagles achieve the highest wrestling GPA in the nation two times.



Fred Garcia

Assistant Coach

Fred, a graduate of fellow Eastern Wrestling League member Lock Haven, completed a stellar wrestling career that included over 100 career wins and three trips to the NCAA Division I National Championships. A Pennsylvania State Athletic Conference

Champion and three-time EWL runner-up, Garcia is also a counselor and clinician for the Rob Wallers All-American Wrestling Camp, working camps throughout several wrestling hotbeds in the U.S. over the past six years.

Mike Fusilli

Mike was a three time All-American, two time finalist, and one time NCAA champion for Ithaca College. He ranks fourth in career wins at Ithaca with 115 and holds the school record for fastest fall in ten seconds. In 1988, Fusilli placed sixth in the NCAA Championships at 190 pounds before improving to second at the same weight in 1989. For the 1990 season, he moved up to heavyweight where he won his championships with a 36-8 record. Fusilli was a three time All-State selection in New York for his performance in the New York Intercollegiate Championships and was a three time East Region champion. His senior year, he was awarded the Ben Light Award for outstanding male senior athlete, and in 1997, he was inducted into the Ithaca College Athletic Hall of Fame.
