**Weigh Ins:** 10:30am-12:00pm, Skin Checks are mandatory.

**Site:** Allegany Community Center, 3677 Administration Drive, Salamanca, NY, 14779

**Eligibility:** 1<sup>st</sup> & 2<sup>nd</sup> year wrestlers only, age determined as of January 12<sup>th</sup>, 2019.

**Entry Fee:** \$15 (\$17 if registering online) per wrestler pre-registered, must be received by January 9<sup>th</sup>, 2019.

\$20 per wrestler at the door. NO REFUNDS FOR ANY REGISTRATION. No phone registrations accepted.

**Team Discounts:** \$12 per wrestler when you register 10 or more on a team. All registrations must be mailed together and received by January 9<sup>th</sup>, 2019 to receive the team discount. If you are pre-registering a team online, it is \$14 per wrestler.

**Admission:** \$3 adults, \$1 students, Children under 5 free. Only 3 Coaches Admitted Free.

**Awards:** Each wrestler will receive an award after their third match.

*Cafeteria will open at 10:00am and remain open until 5:30pm.*

This is a beginners wrestling tournament to provide match experience to new wrestlers. Every effort is made to pair each wrestler based on age, weight, and experience. Each wrestler will receive a bout sheet that he/she will carry into weigh-ins. Bout sheets will be collected prior to each match in an effort to pair wrestlers. All wrestlers will compete in three individual matches. If within the first two matches a wrestler is pinned within 30 seconds, the official will restart the match in neutral position to allow for more mat time. The wrestler who pinned his/her opponent is awarded the win. When the wrestlers have completed his/her three matches of the day, they will be given their award.
