**Divisions: 11&12:** Periods 2 -1 -1 min (Overtime 1 min/ 30 sec. ride out)  
PIAA Referee’s decision is final; Proof of age required, if contested by Head Coach  
PIAA Modified - Double Elimination. Two or Less in any Weigh Class may be moved up a weight class.  
Wrestlers may enter more than one age Division (double entry fee), but not more than one weight class per age Division. Bouts will not be held to accommodate multiple entries.
